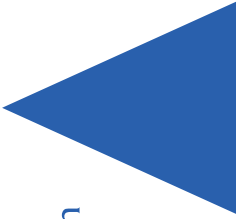

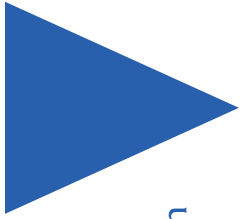

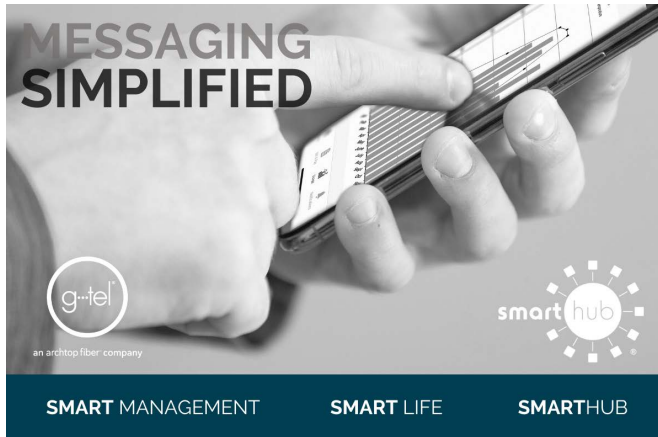

ANNOYANCE CALLS

If you receive a malicious or annoying phone call hang up. Don't keep talking. That is what the caller wants. If the calls persist, please contact the Telephone Business Office. We will work closely with you and police officials to catch offenders.

It is a crime under both Federal and New York law to make a telephone call for annoying or harassing purposes or, in the case of the Federal law, to knowingly permit a telephone under one's control to be used for such purposes. This includes calls in which the caller remains silent, as well as those in which the offender is threatening or obscene. The penalty under the State law can be imprisonment for one year and a \$1,000 fine, and, under the federal law imprisonment for six months and a \$500 fine.

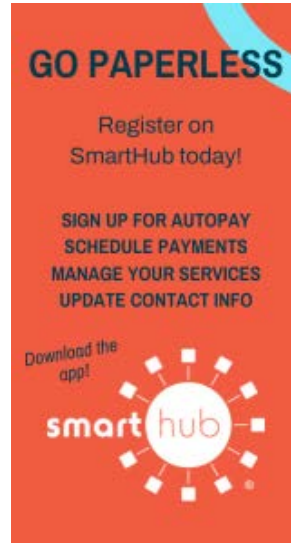

OUR PAYMENT POLICY

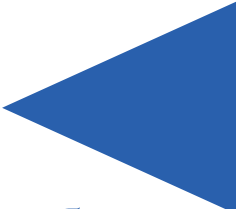
Do you know what we expect of you? We have outlined our payment and deposit policy for your benefit.

1. Telephone bills are mailed by the 1st of each month. These bills are due when rendered. Payments received after the 23rd of each month will not be credited until the following month.
2. If payment is not received by the date as stated above, a final disconnect notice is mailed. If you have a problem that prevents you from paying an overdue bill, you may be eligible to contract a Deferred Payment Agreement. The DPA is based on your ability to pay and requires you to pay current charges when due
3. If you fail to pay overdue bills, we may suspend and/or terminate your telephone service. This action would be taken only after you have been given notice and advised of the availability of a Deferred Payment Agreement (DPA).

We know our customers expect good service from us. Your continued cooperation can help us both achieve our goals.

OUR DEPOSIT POLICY

New customers are exempt from paying deposits unless the information they supply upon application for their service proves they were past customers with a poor financial rating with the company. If a deposit is required, the amount is based on an existing customer's payment history with the company.

Persons who receive Supplemental Security Income, Medicaid, Food Stamps, Aid To Families with Dependent Children or Temporary Assistance for needed families (LIHEAP) are exempt from deposits when establishing service.

Simple interest at the rate specified by the New York Department of Public Service (DPS) shall be credited or paid to the customer while the Company holds the deposit. When the service is discontinued, the deposit is applied against the final bill, and any balance is returned to the customer.

LATE PAYMENT CHARGE

If payment is not received within 23 days from the billing date, a late payment charge of 1 1/2% per month will be applied to all amounts previously billed, excluding one month's local service charge, but including arrears and unpaid late payment charges.

GTel's intent is to help reduce the Company's problem of late payment of bills. There will be no additional cost incurred to our customers who keep their bills current.



Billing Terms



TERMS ON YOUR MONTHLY BILL

BASIC LOCAL SERVICE INCLUDES:

- ACCESS LINE CHARGE**
the monthly charge for the telephone line into your house which allows you to make local calls and receive incoming calls.
- LATE PAYMENT CHARGE**
a charge of 1 1/2% applied to your balance due, excluding the current month's local service.
- (ARC) ACCESS RECOVERY CHARGE**
a monthly charge to your local exchange carrier to recover part of the revenues lost through FCC required reductions to access rates.
- FCC ACCESS LINE CHARGE**
a mandated Federal Communications Commission monthly charge to all customers that provides access to the long distance network.
- SERVICE ORDER CHARGE**
a charge to process requests for changes in your phone service.
- NON-PUBLISHED SERVICE**
a monthly charge for phone numbers which are not published in our directory or given out through directory assistance.
- SERVICE RESTORAL CHARGE**
for reconnection of service after it has been suspended or terminated for non-payment.
- RETURNED CHECK CHARGE**
for a check returned to the bank due to insufficient funds for any part of basic local service.
- COUNTY 911**
this fee is assessed on behalf of Columbia County to pay for the costs of establishing, upgrading and operating the emergency telephone system. Each household or business pays a small monthly fee for 911 services on each telephone/access line.

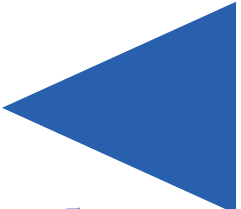

ALL OTHER LONG DISTANCE SERVICE INCLUDES:

- Inter-state calls are those made between states.
Intra-state calls are those made within the state.
LATA – stands for Local Access and Transport Area and designates a specific geographic calling area.
Our LATA includes the 518/838 area codes.
Inter-LATA calls are those made between LATAs.
Intra-LATA calls are those made within our LATA.



Consumer Information & Responsibilities

BILLING INFORMATION

Telephone bills are rendered the first of each month and payment is requested by the 23rd of each month.

When payment is made in person, please present the entire bill; when mailing please enclose payment stub.

Charges for local service and equipment are billed one month in advance. Charges for toll or long distance calls are billed in arrears, prior to date of the bill.

Good credit ratings are established by promptness in paying bills, so payment by due date helps to insure good credit. If you can't pay by the due date, call the Business Office and we will try to make suitable payment arrangements. Customers who do not meet their payment obligations may have their service interrupted.

If service is temporarily disconnected for non-payment, all old charges billed for service must be paid before your service can be reconnected.

SERVICE DISCONNECTED FOR NON-PAYMENT

If you do not pay your bill by the specified due date on the suspension notice enclosed in your telephone bill, GTel will suspend your service. You will not be able to use your telephone. For reconnect to occur, all old charges must be paid in full.

SERVICE CLASSIFICATION

A residential telephone service will be changed to business if used primarily or substantially for business purposes (business nature), or if a residential number is advertised in connection with the sale of products and services.

OTHER BILLING

INFORMATION AND CREDIT

All bills are assumed to be correct unless the Business Office is notified of the bill in question.

Credit for interrupted service – if your phone is out of order, and you have checked your customer-owned equipment or wiring, please call our Repair Service at (518)537-Help (4357) to get it repaired. Trouble found and caused by customer-provided equipment will not receive credit for any outage.

ALL PAYMENTS

Should a bank return your check because of insufficient funds and your return item was a late response to a service disconnection notice, we may turn off your service. GTel may make an attempt to contact you concerning the returned check. If we cannot reach you, we may turn off your service. There is a charge for any returned check.

TRACING ANNOYANCE CALLS

Call Trace is automatically on your phone line. To trace an annoyance call, you must first hang up, pick back up and dial *57 and follow the recorded instructions. Please contact our Business Office once you've completed the trace. GTel will work closely with law enforcement in identifying the caller.

*** Note:**

For each completed trace, \$1.50 will apply.

Why Won't My Phone Work?

That depends on whether the problem is in your telephone set, the wiring inside your home or office, or in the outside lines and switching equipment that GTel uses to provide you with service. Simple tests can help you determine whether or not to call GTel repair for assistance, see below for further instructions.

How To Troubleshoot

These tests can help you determine why your phone isn't working:

- (1) Check to see if all your telephones are plugged in and the handset is hung up properly.
- (2) Perform a visual inspection of all exposed wiring and connections for damaged or loose connections.
- (3) If you have phone accessories - such as answering machines, speaker phones, cordless phones, security system or night bells - make sure that equipment is work-

ing. If your telephone service works without any of the added equipment, the problem may be with the accessories.

- (4) If you have only one phone and it unplugs, take it to a friend's home or office and plug it in. If it doesn't work there, you probably have a phone equipment problem.
- (5) If you have two or more phones, unplug all of them. Then try each one - one at a time - in each phone jack or outlet. If one phone doesn't work anywhere, you probably have a phone equipment problem. If none of the phones work in a particular jack, you may have a jack problem.

Our Repair Service Center Can Help Isolate The Problem

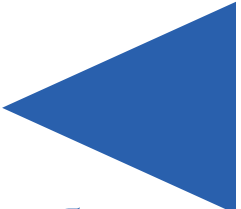
When you call our Repair Center with a service problem, we'll do our best to locate and clear the trouble. In some cases, we cannot identify the problem without sending a repair technician to your home or office. There may be a charge for this repair visit. We have a trip charge that is applied when our repair technician makes a trip to your house or office, at your request, and finds the only trouble with your telephone service is due to a problem in your personally owned equipment, including jacks and inside wiring. **The trip charge is for travel costs; it is not a repair charge.** Repair of your equipment or wiring is available at **time and material rates.**

If the trouble is found to be in our lines or switching equipment, we will take quick action to correct the problem at **no charge.**

If The Problem Is In Your Jack Or The Wire That Runs Through Your Home or Office

You have three options:

- (1) Hire GTel to repair your inside wiring. Call 518-537-4835. If you subscribe to our optional Whole-Home Network Care Plan, we will repair your jack or inside wiring at no charge. If you don't subscribe, we will be happy to repair the problem at our standard labor and material rates.
- (2) Hire any independent contractor or home repair expert to repair your jack or inside wiring.
- (3) You can repair the problem yourself.

If The Problem Is In GTel's Outside Lines Or Switching Equipment

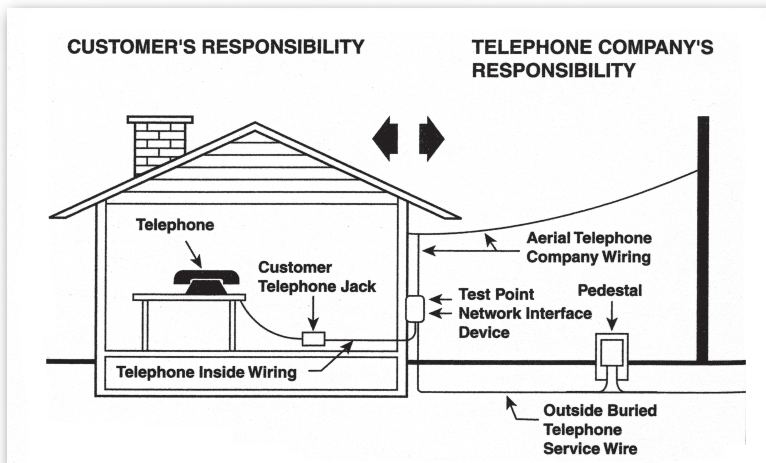
We will take quick action to correct the problem, at no charge.

If The Problem Is In Your Telephone Set

Follow the instruction on your warranty or contact your equipment retailer. GTel cannot repair your telephone equipment.

LOCAL CALLING

WITHIN YOUR LOCAL CALLING AREA:

Listen for the dial tone, then dial the listed number. Give the called party time to answer, about 10 rings, before you hang up. Your local calling area is shown opposite your exchange.

FROM: GERMANTOWN *Numbers beginning with 537*

You can make local calls to numbers beginning with:

537 Germantown, 249, 267, 567, 653, 671, 697, 710, 721,
751, 821, 822, 828, 965, Hudson, 851 Claverack

All other 518/838 calls will be toll.

Germantown Telephone customers who dial a local call within the 845 area code must dial 1 + 845 + NUMBER

All other 845 calls will be toll.

LOCAL MEASURED SERVICE

All calls placed to Rhinebeck (845-876) and (845-871), Copake (518/838-329), and Pine Plains (518/838-398) will be billed by GTel on your local bill as Local Measured Extended Area Service. These calls will not be included with any toll discount plan. The rates for these calls are charged by the minute and time of day. Please contact the Business Office at 518-537-GTEL (4835) for more information regarding these rates.

LONG DISTANCE DIALING

Long Distance Dialing Within The 518/838 LATA

Please carefully read the new dialing instructions. GTel customers do not need to dial the digit "1" before making toll calls within the **518/838 area code.** **You will still be charged the standard toll rates even though you will dial these numbers as if they are local calls.** The prefixes of the telephone numbers which are within your local calling area are listed under Local Dialing Instructions on Page 10 of this directory. Calls to any other number within your area code which are not a part of your local calling area will continue to incur a long distance charge. If you are unsure as to the applicability of a long distance charge to a specific call, please call the Business Office at (518)537-GTel (4835) for assistance.

Customers should continue to dial a "1" on all calls to places outside the 518/838 area code.

Long Distance Dialing Out Of The 518 LATA

GTel customers may choose one of several available long distance companies to be their primary carrier. Regardless of which carrier you choose, the procedure for long distance dialing using your primary carrier is as follows:

1 + Area Code + Local Number

To place a long distance call to points out of the 518/838 area using a carrier other than your primary one, dial as follows:

10 + 10 + Carrier Code + 1 + Area Code + Local Number

EQUAL ACCESS

GTel offers Equal Access to all subscribers. Equal Access is a service in which customers select a primary long distance company to handle their calls to places outside the Germantown LATA.

The choice of a long distance company should be well planned. Just as your calling needs may differ from someone else's, long distance companies can differ in what they offer.

Employees of GTel cannot help you choose a specific long distance company to handle your long distance calling outside of your LATA. We can offer some suggestions to help you select a company that fits your needs and budgets.

You may change your primary long distance company by contacting a GTel Service Representative. You may change companies at any time and as often as you wish, however, a charge of \$5.50 per line is applied each time you change.

If you are a new customer moving into the GTel service area, you will be asked to select a long distance company at the time you place your order. Once you have made your selection, the charge for changing companies is \$5.50 per line.

New York Area Code Map



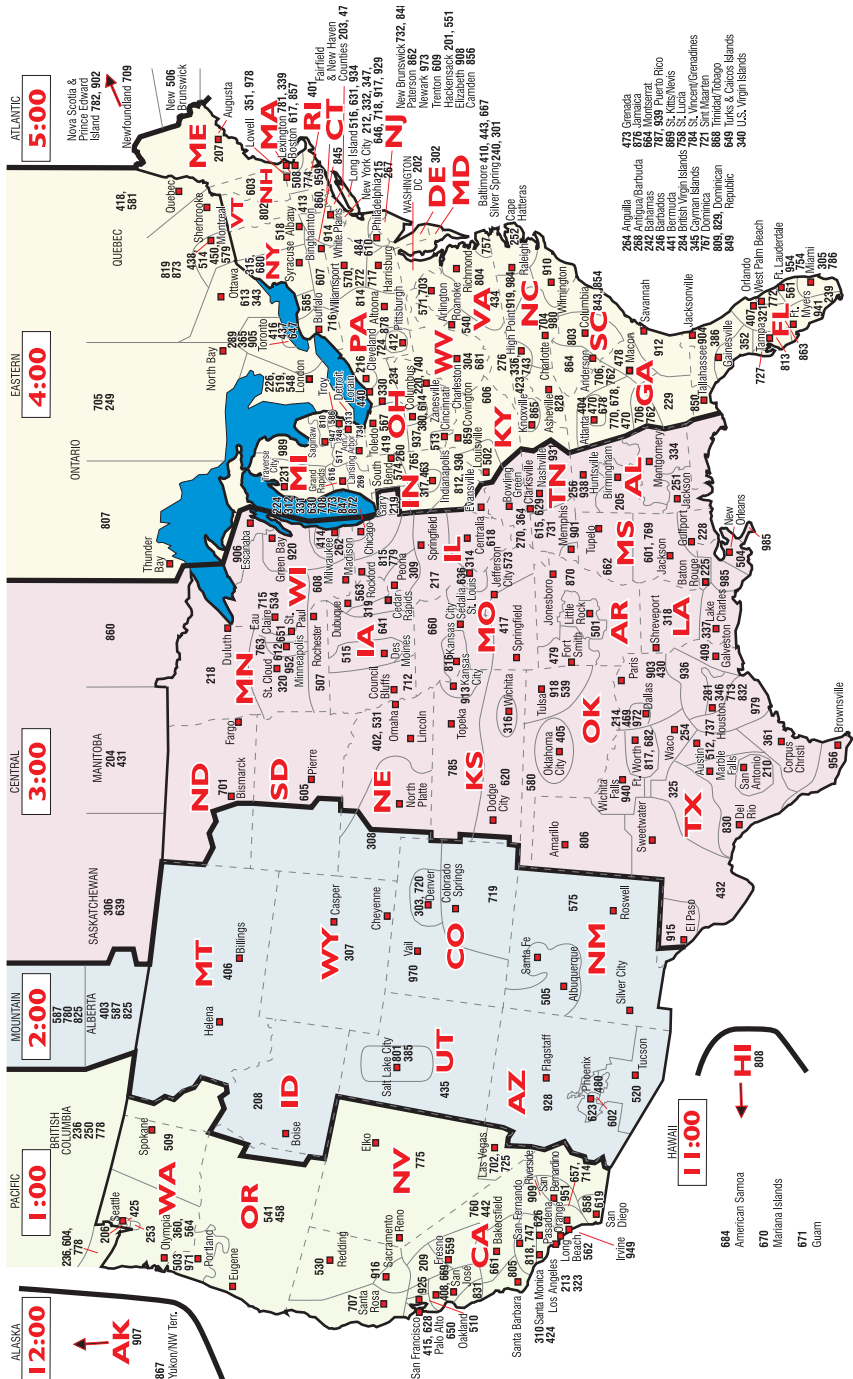

CALL WAITING – Expecting an important call doesn't mean staying off your phone. With call waiting, your calls still come through, even when you are engaged in a conversation. A call waiting signal is heard to indicate to the person engaged in conversation that a second caller is attempting to dial in. Allows the customer to put the first caller on hold to answer the second caller. Customer can actually alternate between callers if so desired.

CALL WAITING/WITH OPTION TO CANCEL CALL WAITING – Allows customer to cancel call waiting before or during a telephone call. Once the feature is connected to your line, to deactivate call waiting, simply dial *70.

CALL FORWARDING – Call forwarding lets you redirect incoming calls to another specified telephone line within the continental U.S.A. When activated, this feature will automatically forward your incoming calls without the assistance of an operator. The calling party is billed for the initial call, while the customer is responsible for the forwarded costs that may occur in forwarding the calls. To activate call forwarding, simply dial

*72, listen for three beeps, then dial the number to be forwarded, listen for three beeps and hang up. To deactivate call forwarding, dial *73, listen for three beeps and hang up.

DISTINCTIVE RINGING – Distinctive ringing enables you to have an additional phone number associated with a single access line. The primary line will have a normal ring, while the other number will have its own distinctive ringing pattern for identification of incoming calls. You now can assign one number to yourself and one number to others in your household.

CALL ID – Call ID lets you see the number of each person calling you before answering the phone. We now offer Call ID on your TV. This service is available if you subscribe to Call ID and our new digital TV.

Notes about feature:

- CALL ID may only display numbers from within your defined calling area. Other calls will be displayed as "out of area" or "private number" for numbers not available.
- Many telephones are Call ID capable. If you have a telephone that does not offer the Call ID feature, an additional piece of equipment called a Call ID Box can be purchased.

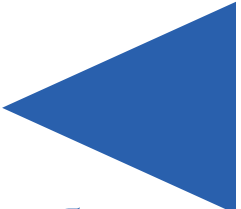

YOU CAN NOW OWN YOUR TELEPHONE, INSIDE WIRING AND OUTLETS; IF YOU HAVE A PRIVATE LINE OR IF YOU HAVE A PARTY LINE

The Federal Communication Commission's registration program gives you the choice of either purchasing and directly connecting registered telephones to the telephone network, or continuing to get and pay for telephone service exactly as you do now. A registered telephone is a set authorized by the FCC for direct connection. It carries specific identification provided to manufacturers by the Commission. The FCC program requires you to contact the telephone company before connecting your equipment.

GTel will sell you your existing telephones, if you wish. Any customer with a private line or party line can connect his own wiring to a telephone company connecting point. All wiring must be done as specified in regulations which the telephone company will provide to you upon request.

The choice is yours, but please remember where a service difficulty or trouble report results from customer-provided equipment connected to the Telephone Company lines, a charge for the visit by the Telephone Company will apply. This charge applies even if the connection is in accordance with tariff regulations. The charge per visit is \$25.00.

DUAL NAME LISTINGS

Dual name listings service is available to residential customers. It permits the listing in the telephone directory of names of two people with the same last name. There is no monthly charge for this service. The dual listing pertains only to the main or primary listing.

FREE COMMUNICATION CONSULTING

If your business is dependent on good telephone communications and you are considering expanding your facilities, moving people and departments or simply wondering how you might improve your internal or external communications...Let us help you.

With all options, local calls and non-chargeable calls such as 911, repair service, 800, 855, 866, 877 and 888 numbers can still be made. This service is available to all GTel customers.

PRE-WIRE

For prewiring of new homes, apartments or commercial buildings, call your local telephone Business Office.

RATES AND SERVICE INFORMATION AVAILABLE TO THE PUBLIC

Upon request, the Business Office will provide customers with information on rates and services. Copies of our Tariff are available at our Germantown office for inspection.



SEASONAL SUSPENSION OF SERVICE

UPON REQUEST the Telephone Company will suspend a subscriber's telephone service, during which time the equipment will be left in place and the subscriber's directory listing continued. The following rates and regulations apply:

1—An allowance is made of one-half the monthly schedule for local service and any equipment owned by GTel.

2—Such allowance is not made for suspension of less than one month nor for more than six months.

The seasonal rate will become effective on the first of the month following the receipt of the request for disconnections. When you wish to reconnect the telephone service, ADVISE THIS OFFICE at least one week in advance and the telephone will be reconnected and ready for you to use when you arrive. If you are calling from outside our service area, please call Toll Free 1-888-GTEL NOW.

FRAUDULENT USE

Obtaining telephone service fraudulently, any person who, with the intent to avoid the payment of the lawful charges therefore, obtains or attempts to obtain any telephone service by charging such service to an existing telephone number or calling card number without the authority of the subscriber, thereto or the lawful holder thereof, or to a non-existent, revoked or cancelled calling card number, or by rearranging, tampering with or making connection with any facilities or equipment of a telephone company, or by the use of any other fraudulent means, method, trick or device, is guilty of a misdemeanor or, in some cases, a felony.

CHARGES FOR 900 MESSAGES FOR NON-TELECOMMUNICATION SERVICES

For billing disputes or inquiries, call our Business Office at (518)537-4835. You have 60 days from the date of the bill to dispute a billing error. You have the right to withhold payment of the disputed charges during the billing error review. No collection activity for disputed charges will occur while the charges are under investigation. After investigation, if it is determined that the disputed charges are legitimate, AT&T or the information provider may proceed with outside collections against your account. Your local and long distance service cannot be disconnected for non-payment of 900 charges. Failure to pay legitimate 900 charges may result in involuntary blocking of access to 900 services. Voluntary blocking of access to 900 services is available upon request from your local exchange carrier.

STATEMENT OF NONDISCRIMINATION

(Not all prohibited bases apply to all programs.) Any person who believes himself, or any specific class of individuals, to be subjected by this organization to discrimination prohibited by Title VI of the Act and Rules and Regulations issued thereunder may, by himself or a representative file with the Secretary of Agriculture, Washington, D.C. 20250, or the Rural Electrification Administration, Washington, D.C. 20250, or this organization, or all, a written complaint. Such complaints must be filed not later than 180 days after the alleged discrimination, or by such later date to which the Secretary of Agriculture or the Rural Electrification Administration extends the time for filing. Identity of complainants will be kept confidential except to the extent necessary to carry out the purposes of the Rules and Regulations.

TELEMARKETING (DO-NOT-CALL REGISTRY)

To address consumer concerns about unwelcome telemarketing calls, the Federal Communications Commission (FCC) and Federal Trade Commission (FTC) have established a national Do-Not-Call Registry. The registry applies to all telemarketers (with the exception of certain non-profit and political organizations) and covers both interstate and intrastate telemarketing calls. Commercial telemarketers are not allowed to call you if your number is listed on the registry.

You can register your phone number for free and it will remain on the national Do-Not-Call Registry for as long as you don't remove it. You may remove your name/number from the list at any time. The Do-Not-Call Registry will not prevent all unwanted calls. It does not cover the following:

- Calls from organizations with which you have established a business relationship;
- Calls for which you have given prior written consent;
- Calls which are not commercial or do not include unsolicited advertisements;
- Calls by or on behalf of tax-exempt non-profit organizations.

Consumers may register their residential telephone number, *including wireless numbers*, on the national Do-Not-Call Registry at no cost by telephone or on the Internet. To register by telephone, consumers may call 1-888-382-1222. For TTY call 1-866-290-4236. You must call from the phone you wish to register. You may also register by Internet at: www.donotcall.gov. Inclusion of your telephone number on the national Do-Not-Call Registry will be effective three months following your registration.

YOUR RIGHTS AND RESPONSIBILITIES AS A RESIDENTIAL CUSTOMER

As a GTel customer you have rights and responsibilities.

These rights and responsibilities result from New York State Public Service Commission (PSC) Rules Governing Provision of Telephone Service to Residential Customers.

QUESTIONS OR PROBLEMS

Contact us as soon as possible if you have any questions or complaints about your telephone service. We will try to give you a prompt answer. Our representatives are available to help you between 8:00 a.m. and 4:30 p.m., Monday, Tuesday, Thursday, Friday and between 9:00 a.m. and 4:30 p.m. on Wednesday.

To get your questions answered fully and as quickly as possible we suggest you call our Business Office at 518-537-4835. If you prefer, you can write to GTel, P.O. Box 188, Germantown, NY 12526. Please include your telephone number. Give us as much information about the problem as you can.

Whether you phone or write, we will do our best to give you a prompt reply.

If you are still not satisfied, you can call or write to the New York Department of Public Service (DPS) www.dps.ny.gov/complaints at Three Empire State Plaza, Albany, New York 12223. They have a staff available to give you assistance if you request it. The telephone number is 800-342-3377 (toll free) between 8:30 a.m. and 4 p.m. on business days.

While your complaint is being considered by the Public Service Commission, we will not disconnect your service for failure to pay the amount in question. However, all undisputed bills must be paid when due to ensure continued service.

BILLING

We have a responsibility to provide reliable telephone service to our customers, and you have a responsibility to pay bills for telephone service promptly by the 23rd of each month.

Large Print Bills – Upon written request, large print billing statements will be provided to the customer no later than 60 days after the date upon request is received.

Where to Pay – The most convenient way to pay is by mail, using the return envelope enclosed with your bill. You can also pay in person at our Business Office, on line or by monthly auto charge.

DEPOSIT POLICY

New Customers – If you are a new customer who has not established a payment record with our company, we will not initially require a deposit.

Customers 62 Years of Age or Older – If you are 62 years of age or older, we will not ask you for a deposit unless your service was terminated for nonpayment within the past six months.

Customers Who are Delinquent – If you are delinquent in your bill payments, you may be required to pay a deposit or an additional deposit. Delinquent in payment means that a customer has received two bills without making payment of one-half of the total of the two bills.

Customers Whose Service Is Terminated – If your service has been terminated for nonpayment of bills in the last six months, you may be required to pay a deposit.

SOME FACTS ABOUT DEPOSITS

Amount Of A Deposit – If we do require a deposit, the amount is based on two times the average monthly bill.

Payment of Deposits – If you are unable to pay the required deposit amount and request an agreement, you can pay the deposit in installments over a period not to exceed 6 months.

DEPOSIT INTEREST AND REFUNDS

We pay interest on your deposit at a rate specified by the Public Service Commission. We can hold a deposit for one year. If you have not been delinquent (as described above) in the past 12 months, the deposit and interest earned will be applied to your bill, or refunded to you if you request. Otherwise we will credit your account with the earned interest, but hold your deposit. The account will be reviewed again once a year to see if it qualifies for a refund.

FINAL TERMINATION NOTICE

If you fail to pay overdue bills or a deposit, we can terminate your service. However, before this is done, we would forward a Termination Notice so that you would have an opportunity to arrange payment and avoid interruption of your service.

If you are eligible under the Rules of the Public Service Commission, we will offer you a deferred payment agreement at least six days before we terminate your service. If you need assistance in understanding the deferred payment agreement, you may obtain the assistance of the PSC (see Deferred Payment Agreement). If you sign a deferred payment agreement, we will not disconnect your service as long as you make the agreed upon payments.

If there is no question about the bill and you fail to pay the amount shown on your termination notice or refuse to sign a deferred payment agreement, your service will be terminated. Service will not be terminated if you qualify for the special protection described in the section on Special Protection.

WHEN SERVICE CAN BE TERMINATED

We are allowed to terminate residential telephone service for non-payment between 8:00 a.m. and 4:00 p.m., Mondays through Thursdays. We cannot terminate service on a public holiday, the day before a holiday, any day our Business Office is closed, or on December 23, 26, 30 and January 2.

RECONNECTION OF SERVICE

If we terminate your service, we will reconnect it within 24 hours after you have paid the amount due or signed a deferred payment agreement and made the down payment.

If service is terminated, there is a charge to reconnect the service.

DEFERRED PAYMENT AGREEMENT

If you have a financial problem that prevents you from paying your bills, you may be eligible to sign a deferred payment agreement. It must be fair and based on your ability to pay. The amount deferred can be no more than \$150. Any amount due above that must be paid before a deferred payment agreement can be offered. We may require you to make a down payment which will not be more than 20% of the deferred amount or three times your average monthly bill, whichever is less. The balance of the deferred amount can be paid together with your current bills, over a period not to exceed five months. The agreement can be changed if you can show us that there are significant changes in your financial condition beyond your control. The DPS has a staff that will help you in reaching an agreement with us if you request it. You may reach one of their representatives at 800-342-3377 (toll free) between 8:30 a.m. and 4 p.m. on business days.

SPECIAL PROTECTIONS

Medical Hardship – If you are unable to pay your bill and a medical emergency exists in your household, we can help you. If you file a medical certificate with us, signed by your doctor or an official of your local board of health, on their official stationery, we will continue your service for 30 days.

The certificate can be renewed, but to do this your doctor or official of your local board of health must explain the medical emergency or why service is needed and you must explain why you are unable to pay your telephone bills. We will not terminate your service during the emergency, but you are still responsible for your bills.

Elderly (62 or older), Blind, Disabled – If you are 62 years of age or older, blind, or disabled, and all those living with you are too (or not over 18 years old) we will continue your service for an additional 20 days. We will contact you by phone before the termination date to try to work out a fair payment plan. If you qualify under this protection, you should notify the GTel Business Office.

THIRD PARTY NOTIFICATION

All residential customers may choose a third party to receive copies of all credit notices. A third party notice may keep your service from being turned off by mistake.

You may choose a relative, a friend, a member of the clergy or a community agency to be a "third party" for you if they agree to act on your behalf. A third party will receive copies of any credit notices we send to you because of overdue bills. The third party can contact us on your behalf and help you work out payment terms with us. Remember, however, that the third party is NOT responsible for paying your bills.

APPLICATION FOR SPECIAL RIGHTS PROGRAM

If you believe you may be entitled to certain protections as described, please call the Business Office at (518)537-4835 so that we may mail you the proper application forms.

GTel enjoys a good relationship with our customers and stands ready to assist customers in making it possible to continue to enjoy telephone service by making payment arrangements when special circumstances arise.

We sincerely hope you are satisfied with the telephone service we are providing, but if at any time you have a problem, please contact our Business Office and give us an opportunity to correct any problem that may exist.
